## 2010 Annual Meeting Registration and Membership

The 2010 SDA annual meeting takes place at the Crowne Plaza Hotel in Knoxville, Tennessee. The meeting dates are October 7-9.

Members must register for the meeting via a web form (see below). When registering, members will have the option of paying by credit card via Paypal or paying by putting a check in the mail.

If you choose to pay by web/credit card, you will be taken to Paypal's website to complete the payment. *Please do not register for membership or for the meeting with the web payment option unless you intend to use your credit card to make an immediate payment.* The aim of the web system is to make it easy for members to join and pay; it is not intended as a reserve now/pay later system for the meeting.

### Hotel Information

The SDA group rate is \$96 (or \$106 for a king bed). You can [make your reservation online](#), or call the hotel at 865.522.2600.

Federal employee room rates are available for up to 15 rooms. Current CONUS rates for Knoxville are \$84 for Knoxville. To be eligible for this rate, federal government employees must book their room on the SDA website for the \$96 rate, then submit their room request to David Redburn ([david.redburn@furman.edu](mailto:david.redburn@furman.edu)) before September 15. David will provide a rooming list to the hotel.

Your small dog (under 50 pounds) or cat is welcome in the hotel room for a \$25 fee, in case you don't go anywhere without Fido or Fluffy.

Parking at the Crowne Plaza is \$6/day for self-parking and \$10/day to valet park. For those not staying at the hotel, self parking is \$8/day.

### About Knoxville

Getting around downtown Knoxville is easy. Almost everything is walking distance to the hotel. If you don't wish to walk, the [Knoxville Area Transit trolley](#) comes by the front door of the hotel about every ten minutes (less frequently on Saturday). Riding the KAT trolley is free, and you can take the [Orange Line trolley](#) to the University of Tennessee and to points around downtown.

Dining and drinking options are plentiful in and around the Crowne Plaza. The graduate students at the University of Tennessee will provide a dining guide as well as a bar guide to places within walking distance of the hotel.

## Plenary Speakers

This year we have two very interesting plenary luncheons planned for the annual meeting. On Friday, October 8, **Katherine M. Donato** will be our guest speaker. On Saturday, October 9, **Dudley L. Poston** will be our guest speaker.

Dr. Donato will give a presentation titled “Mexican Immigrants and Public Resources: Costs and Contributions.” Her co-authors are Douglas S. Massey, Princeton University, and Brandon Wagner, University of North Carolina, Chapel Hill). Dr. Donato is a Professor and Chair of the Department of Sociology at Vanderbilt University. She also currently serves as the editor of *American Sociological Review*. Her research interests include immigrants and the U.S. economy, social determinants of health, international migration between Mexico and the U.S., and gender and ethnic stratification.

Abstract: A major shortcoming of most prior research on immigrant’s use of social services and tax payments is the inability to disaggregate findings by legal status. Federal data from the Census and Current Population Survey only distinguish between citizens and other foreigners, and few data sets contain information sufficient to identify undocumented migrants with any reliability. The one exception is the Mexican Migration Project, which has compiled information on contributions of, and services used by, Mexican migrants in all legal statuses for more than two decades. In this presentation, we use these data to understand the shifts and patterns of service use and contributions reported by the largest immigrant population in the United States. Our findings are noteworthy in two ways. First, they reveal that legally authorized migrants are more likely than their unauthorized counterparts to rely on social and health services. Second, among recent arrivals, whereas authorized immigrants are more likely to make contributions, the unauthorized are less likely to use services, compared to their counterparts entering before 1986. We argue these findings reflect the restrictive immigration policy context that began after 1986 and has since intensified, whereby immigrants increasingly fear deportation and avoid federal and local government officials.

Dr. Poston will give a presentation titled “China's More Than 50 Million Extra Boys: What are Some of their Societal and Demographic Implications?” Dr. Poston is Professor of Sociology and Abell Professor of Liberal Arts at Texas A&M University. His research interests include China and Korea, quantitative methods, sex and gender, human ecology, and gender.

Abstract: China has had an unbalanced sex ratio at birth (SRB) since the mid-1980s. For the past several years China's SRB has been 120 (120 boys born each year per 100 girls born). Accordingly, there have already been born in China around 44 million boys who when they reach marriage age will not be able to find Chinese women to marry. This number will reach 51 million by the year 2020 only if China is able to drop its current SRB of 120 down to 109; if the SRB remains at 120, there will be around 55 million extra boys in the year 2020. This is a really big number, one-sixth the size of the total US population and more than twice the size of the population of Texas, an astoundingly large number of extra men who won't be able to find Chinese women to marry. What are some of the demographic and societal implications of the largest number of unmarried men in a single country in recorded human history?

## SDA Banquet

The SDA banquet will be held on Friday, October 8, from 7:00 to 10:00 p.m. at the historic Louisville & Nashville passenger railway station on the World's Fair site at the corner of Western Avenue and Henley Street. The station was built in 1904 and designed by Richard Montfort, chief engineer for the L&N Railroad. It was last used for passenger rail in 1968. Scheduled for demolition in the late seventies, the building was resurrected by the Ruby Tuesday's corporation for use as a restaurant during the 1982 World's Fair. Today it pretty much sits empty, so SDA will bring it some life.

When you arrive at the intersection of Henley Street and Summit Hill/Western Avenue, the Victorian style, red-brick station is right in front of you.
