

## Member News

### Kokos Markides receives national prize for aging research!!

GALVESTON, Texas UTMB's Kyriakos S. Markides, PhD, an internationally renowned expert on aging and health issues was awarded the Pearmain Prize from the nationally recognized Edward R. Roybal Institute on Aging at the University of Southern California, Los Angeles. Congresswoman Lucille Roybal-Allard was the keynote speaker at a ceremony attended by several hundred community leaders and guests from USC and UCLA. After accepting the award, Markides delivered the Edward R. Roybal Memorial Lecture, honoring Congressman Roybal, co-founder of the House Select Committee on Aging where he served as its first Chairman from 1983-1993.

The initial recipient of the prize, Markides is best known for his ongoing research of aging among Mexican Americans which he has been conducting since 1976. He is also well-known for coining the term "Hispanic Paradox", referring to the population's relatively favorable health despite high risk factors, especially a lower than average socioeconomic status.

"We are proud that Dr. Markides' work is being recognized and honored with this award," said Dr. Garland D. Anderson, executive vice president and provost at UTMB. "His research on health concerns in the elderly and in Mexican-Americans is important in Texas and the nation."

"I am thrilled to have received this award," Markides said. "My hope is to both continue my study of the multi-faceted aspects of the aging process, while encouraging others within the aging research community to do so as well. In the end we all benefit."

Markides is the Annie and John Gnitzinger Distinguished Professor of Aging, the director of the division of sociomedical sciences in the department of preventive medicine and community health at UTMB, and editor of the Journal of Aging and Health, which he founded in 1989.

An author and co-author of numerous publications, the majority on the health of older Mexican Americans, Markides is also the editor of the "Encyclopedia of Health and Aging", considered one of the most definitive resource guides on aging.

- Demonstrated skills in the analysis of international survey data, including the DHS
- Experience in policy and program-relevant research and communicating research findings to non-technical audiences
- Prior background in training and mentoring, especially in host-country settings
- Fluency in French, Spanish or Arabic, in addition to English, is desirable
- This is a full-time position requiring up to 20% overseas travel.

## Postdoctoral Opportunities

### Minnesota Population Center, University of Minnesota:

The Minnesota Population Center (MPC) has an opening for a post-doctoral researcher to assist in the expansion and improvement of two large databases of United States census and survey data: IPUMS-USA and IPUMS-CPS. The successful candidate would begin in fall 2010.

#### **Responsibilities:**

The post-doctoral associate will work as a member of the IPUMS-USA research team and will play an important role in the improvement and expansion of internal U.S. Census Bureau data files. The postdoctoral associate's responsibilities will include assisting with three main elements of the ongoing 1960 Data Restoration Project: (1) restoring lost records from the 1960 decennial census data; (2) creating new data products from the complete 1960 internal data; and (3) integrating the 1960-2000 internal census files. These responsibilities will require obtaining Special Sworn Status from the U.S. Department of Commerce and working with confidential Census Bureau data in the new Minnesota Research Data Center. Depending on project needs, similar responsibilities may evolve on IPUMS-USA, focusing on data from the decennial census and the American Community Survey. MPC post-doctoral associates are expected to participate in the intellectual life of the center, present research at workshops and scholarly conferences, and publish related research in academic journals. Additionally, as a professional in training, the post-doctoral associate is expected to pursue at least one research project using data from IPUMS-USA, IPUMS-CPS, or the internal Census Bureau data files. MPC post-doctoral appointments are for one year with renewal possible up to total of three years, dependent upon funding and performance.

#### **Qualifications:**

*Required:* Ph.D. in a social science discipline (e.g. Sociology, Economics, History, Geography), with a population-related topical emphasis. Excellent written and verbal communication skills. Excellent computer skills. Demonstrated mastery of at least one major statistical software package (SAS, Stata or SPSS). Must be able to pass background check and obtain Special Sworn Status from U.S. Department of Commerce.

*Preferred:* Research experience using one of the IPUMS databases or any other large collection of census or survey data. Computer programming experience (preferably C++ or Perl, but substantial experience in SAS or Stata is also acceptable). Experience with HTML/XML. Experience collaborating with academics and technical staff in an interdisciplinary environment. A strong interest in U.S. decennial census data.
