#### **University of Colorado Denver, Department Chair**

The Department of Sociology at the University of Colorado Denver is seeking qualified applicants at the rank of Associate or Full Professor for the position of Department Chair. # Johns Hopkins Bloomberg School of Public Health, Assistant or Associate Professor

The Social and Behavioral Interventions (SBI) Program in the Department of International Health is recruiting one full-time tenure track member at the Assistant or Associate Professor level. The research focus of the SBI Program is the design, implementation and evaluation of interventions to promote health and nutrition-related behaviors. We are looking for candidates engaged in research on behavioral and community interventions related to one or more of these problem areas: 1) effectiveness, sustainability and implementation at scale of community, homebased, worksite and social marketing interventions, 2) interventions to reduce over and undernutrition, 3) interventions to improve maternal, newborn and child health outcomes, 4) prevention and control of infectious diseases, and 5) improving acceptance and use of health technologies. Experience in conducting qualitative research, formative research and process evaluations, application of theory and research findings to the design of public health programs and interventions, and the ability to work effectively in one or more foreign languages, are assets.

Required qualifications are an earned doctoral degree in a social science discipline (Psychology, Sociology, Anthropology) or Public Health (with specialization in applied social science, or related field); ability to generate and maintain an independent stream of research funding; three or more years experience in public health research or practice in low- and middle-income countries during or after doctoral studies; at least five articles published or accepted for publication in peer-reviewed journals, two or more with the candidate as first author; potential to contribute to existing courses offered by SBI Program whose focus is qualitative research, formative research and behavior change interventions; and experience in teaching or training. Responsibilities include establishing an independent research agenda through extramural funding, teaching, advising in the graduate program, and service to the community and field of public health.

Women and under-represented minority candidates are particularly encouraged to apply. # **UC Davis, Center for Poverty Research** 2011-2012 SMALL GRANTS COMPETITION

REQUEST FOR PROPOSALS

DEADLINE FOR RECEIPT OF PROPOSAL: Tuesday, January 31, 2012, 5 PM PST

The Center for Poverty Research (CPR) seeks to fund research that will expand our understanding of the causes and consequences of poverty. The goals of this program are to expand research in our Center's core research areas, with sound research design and high potential impact. CPR anticipates funding up to 5 proposals, up to a maximum of \$20,000 per award.

We seek proposals for research connected to our core research themes:

- Labor markets and poverty
- The non-cash safety net, broadly construed to include education and health policies
- Children and the intergenerational transmission of poverty
- Immigration and poverty, especially in connection with the above three areas

Projects using either qualitative or quantitative data sources are eligible for funding. Because of the short length of the performance period, we do not anticipate funding projects that seek to collect new data.

Applicants for small grants must hold a Ph.D. and be in a tenure track academic appointment. The Center is particularly interested in supporting early-career poverty researchers. Competitive proposals for which the PI is an Assistant Professor will be given more weight in the evaluation process. Funding will begin on or before March 1, 2012 and funded activities must be complete by February 28, 2013. A final report and related policy brief will be due no later than March 31, 2013. Receipt of a small grant from the Center for Poverty Research will require a commitment to 1) present the results of the research project at the UC Davis Poverty Center's February 2013 Small Grant Recipient Conference (travel expenses will be paid by the Center); 2) produce a draft paper by February 1, 2012; and 3) write a "policy brief" of two to three pages, based on the research findings, and aimed at a general audience by March 31, 2013. The policy brief will be made available to the public on the Center's website. Funded scholars will be expected to complete at least one paper from the project suitable for academic publication. A draft paper will be due to the Center prior to the February 2013 Conference. All publications should acknowledge support from the Center for Poverty Research. The Center will support expenses such as the PI(s) salary, research assistant's salary, data, software, supplies and research related travel. The budget period is March 1, 2012 to February 28, 2013.

### Post-doctoral Opportunities

#### **Cornell University**

The Cornell Population Center (CPC) invites applicants for the Frank H.T. Rhodes Post-doctoral Fellowships. The start date for the position will be August 15, 2012 and will be funded for 2 years, subject to a satisfactory first year evaluation. Selection will be based on scholarly potential, ability to work in multi-disciplinary settings, and the support of a faculty mentor and CPC affiliate at Cornell who will work closely with the post-doctoral associate. Preference will be given to fellows with research interests in areas broadly related to the CPC's three main foci: families & children, health behaviors & disparities, or poverty/inequality. Especially encouraged are applications from candidates whose research has significance for those countries on which the fellowship's funder focuses – the United States, the Republic of Ireland, Northern Ireland, Vietnam, South Africa, and Bermuda.

The postdoctoral associate will have access to the full range of university resources and receive an annual salary of \$50,000 plus benefits and a modest research/travel account.

Screening of applications begins February 1, 2012, and will continue until the position is filled.

Applications must include: (a) letter of application, (b) curriculum vita, (c) a statement proposing both an individual research project and how the candidate will engage with a CPC faculty affiliate's on-going research, (d) examples of written work, (e) a letter from a CPC faculty affiliate agreeing to mentor the candidate, and (d) three letters of recommendation. PSC expects to have openings for postdoctoral fellows sponsored by NIA and NICHD. Positions to start on or about September 1, 2012. Applicants must have a Ph.D. in demography, public health, or one of the social sciences (e.g. sociology, economics, anthropology, psychology or history) at the starting date.

Applicants for the NIA positions should be intending to focus their efforts during the postdoctoral fellowship on aging related research, broadly defined, while applicants for the NICHD positions should be intending to focus on population research. Selection will be based on scholarly potential and compatibility with the interests of a faculty mentor. Fellows devote most of their time to independent research, but may also take selected courses and/or teach on a light-load basis if opportunities are available.

#### University of Texas at Austin, Population Research Center

The Population Research Center (PRC) at The University of Texas at Austin will have two openings for NICHD-funded postdoctoral positions starting September 1, 2012. These positions are for one year, but are potentially renewable for a second year. The PRC is an interdisciplinary research and training unit of the University of Texas at Austin (UT) that provides infrastructure support services and project development support for a very productive, interdisciplinary group of faculty, postdocs, graduate students, and undergraduate students at UT. Most of the research is concentrated in four overlapping and reinforcing thematic areas: Health disparities, Educational Inequality & Opportunity, Partnership, Parenting, & Human Development, and Work and Stratification.

As part of a research unit with a strong culture of collaboration, postdocs are expected to spend about half of their time working independently and about half of their time working together with research associates.
